Scope of Work

1. Setup and Design

The service provider must provide all the equipment needed for the setup at the venue. There will be three (03) areas to set up mainly:

a. The Conference area to be covered with slippery-proof event flooring (41 x 62 m²) that is safe for all types of shoes, red carpet at the entrance of the venue 15 x 3m² x 2 (two separate carpets) draping and décor for the entire venue (41 x 62 m²), tables and chairs (400 chairs and tables in classroom style), a stage (15x5m²) with couches (panel set-up) consisting of four (04) couches with décor setup, four (04) Audio Visual screens (100-inch screens) with stands and a Public Address (PA) system with five (05) roaming microphones.

b. A demarcated VIP area with a couch set up for 100 guests, dining tables, and chairs for 100 guests.

c. An exhibition area with 50 tables with white tablecloths and 100 chairs covered (2 seats per table). In addition to the set-up, the successful service provider must provide executive bathrooms for the event. Four (04) double unit bathrooms four (04) male and four (04) female with basins, hand wash, hand lotion, and paper towels.

2. Catering and refreshments

a. Catering should be provided for the attendees.

Caterers are strictly required to be on time.

- 400 x beef and chicken burgers with chips and a drink

- 100 x plated meals for the VIP area (2 starch, 2 salads, 2 veg, grilled chicken and beef stew, and beverages)

b. An all-morning tea and coffee station inclusive of all condiments

- Includes tea (five roses, rooibos, etc.), and coffee (Nescafe, Ricoffy, etc.) with milk, sugar, creamer, sweetener, honey, etc.

c. Water for the conference area (to be placed on the tables) – 400 x Still Water

d. Water for the VIP (to be placed on the tables) - 70 x Still Water and 30 x Sparkling Water

Lunch set up must be ready at 11H00

PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

NB: BEFORE COMPLETING THIS FORM, TENDERERS MUST STUDY THE GENERAL CONDITIONS, DEFINITIONS AND DIRECTIVES APPLICABLE IN RESPECT OF THE TENDER AND PREFERENTIAL PROCUREMENT REGULATIONS, 2022

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

a) The applicable preference point system for this tender is the 80/20 preference point system.

1.2 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

The maximum points for this tender are allocated as follows:

1.3 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.4 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

 - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
