## **1. Background**

### **Configuration of Joburg Market telephone system**

The objective is to collaborate with service partners to configure the telephone system network, including existing FarSouth PBX, Oracle SBC, SIP trunk, and structured cabling. The vendor will integrate the FarSouth PBX with the Telkom SBC, configure inbound and outbound call routes, and manage necessary network infrastructure tasks.

## **2. Scope of work**

### **2.1 Collaboration for SBC Device Configuration**

- Work with the service partner to configure and integrate with the Oracle SBC (Session Border Controller) device.
- Set up and establish a SIP trunk/peer connection between the Telkom network and the SBC server to ensure proper connectivity and traffic flow.

### **2.2 PBX Configuration for SIP Trunk/Peer Integration**

- Configure the FarSouth PBX to properly integrate with the SIP trunk/peer provided by Telkom for both inbound and outbound call routes.
- Ensure seamless routing of calls via the Telkom SBC server.

### **2.3 Inbound Call Route Configuration**

- Configure inbound routes on the PBX system to direct incoming calls to the respective phone extensions based on predefined rules and criteria.

### **2.4 Outbound Call Route Configuration**

- Set up outbound call routes on the PBX to ensure calls are correctly routed to other network providers or external destinations as per the business requirements.

### **2.5 Structured Cabling and Cable Management**

- Perform a thorough clean-up of existing cables and ensure that all cables are rerun and organized according to structured cabling best practices.
- Label and organize all cables to maintain a tidy and efficient network infrastructure.

### **2.6 Decommissioning of Unused Cables**

- Identify and safely remove old, unused, or redundant cables from the network rack, ensuring that only necessary cables remain for operational efficiency.

### **2.7 Documentation of Network Layout**

- Provide comprehensive documentation of the entire telephone system network, including architectural diagrams, hardware and software configurations, IP addresses, and detailed SIP settings.
- Ensure that all relevant information is included in the documentation for future reference, troubleshooting, and potential system upgrades.

### 3. Deliverables

- Fully configured Oracle SBC and FarSouth PBX system with functional SIP trunk/peer setup.
- Configured inbound and outbound call routes.
- Clean and well-organized cabling infrastructure.
- Decommissioned and properly disposed of unused cables.
- Detailed network documentation including diagrams, configurations, and hardware details.

- Proven experience in configuring FarSouth, PBX SBC devices and SIP trunk/peer integrations.
- Strong knowledge of PBX systems and call routing.
- Expertise in structured cabling and network infrastructure management.

## PREFERENCE POINTS CLAIM FORM IN TERMS OF THE PREFERENTIAL PROCUREMENT REGULATIONS 2022

1.3 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.4 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all

applicable taxes less all unconditional discounts;

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

## **CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)**

This section sets out how personal information will be collected, used and protected by Joburg Market hereinafter referred to as “JM”, as required by the Protection of Personal Information Act. The use of the words “the individual” for the purposes of this document shall be a reference to any individual (bidder) communicating with JM and/or concluding any agreement, registration or application, with the inclusion of each of those individuals referred to or included in terms of such agreement, registration or application.

### **1. What is personal information?**

The personal information that JM requires relate to names and surnames, birth dates, identity numbers, passport numbers, demographic information, education information, occupation information, health information, addresses, memberships, and personal and work email and contact details.

### **2. What is the purpose of the collection, use and disclosure (the processing) of personal information?**

JM is legally obligated to collect, use and disclose personal information for the purposes of:

- Reporting initiatives to the City of Johannesburg Municipality;
- reporting to National Treasury all contracts awarded;
- obtaining information related to Tax Compliance information from SARS;
- Verifying information on the National Treasury database of defaulters;
- evaluating and processing applications for registration on the database;
- compiling statistics and other reports;
- providing personalised communications;
- complying with the law; and/or
- For a purpose that is ancillary to the above. Personal information will not be processed for a purpose other than what is identified (the purpose) above without obtaining consent beforehand.

### **3. How will Joburg Market process personal information?**

JM will only collect personal information for the purpose as stated above. Information will be collected in the following manner:

- directly from the individual;
- from service providers who provided with services or goods to JM;
- from JM’s own records relating to previous supply of services or goods; and/or
- from a relevant public or equivalent entity.

### **4. To whom will personal information be disclosed?**

The personal information may be disclosed to other relevant public or other entities on whose behalf we act as intermediaries, other third parties referred to above in relation to the purpose or who are sources of personal information, service providers such as professional bodies who operate across the borders of this country (trans border flow of information) where personal information must be sent in order to provide the information and/or services and/or benefits

requested or applied for. In the event of another party/ies acquiring all of or a portion of JRA's mandate or functions, personal information will be disclosed to that party but they will equally be obliged as we are, to protect personal information in terms of this policy and the law.

## **5. Consent and Permission to process personal information:**

I hereby agree with the policy and provide authorisation to JM to process the personal information provided for the purpose stated:

- I understand that withholding of or failure to disclose personal information will result in JM being unable to perform its functions and/or any services or benefits I may require from JM.
- Where I shared personal information of individuals other than myself with JM I hereby provide consent on their behalf to the collection, use and disclosure of their personal information in terms of this personal information policy and I warrant that I am authorised to give this consent on their behalf.
- To this end, I indemnify and hold JM not responsible in respect of any claims by any other person on whose behalf I have consented, against JM should they claim that I was not so authorised.
- I understand that in terms of POPIA and other laws of the country, there are instances where my express consent is not necessary in order to permit the processing of personal information, which may be related to police investigations, litigation or when personal information is publicly available.

- A copy of the full JM policy is available
- Individuals are encouraged to ensure that where personal information has changed in any respect to notify JM so that our records may be updated. JM will largely rely on the individual to ensure that personal information is correct and accurate.
- The individual has the right to access their personal information that JM may have in its possession and are entitled to request the identity of which third parties have received and/or processed personal information for the purpose. Please note however, that any request in this regard may be declined if:
  - the information comes under legal privilege in the course of litigation,
  - the disclosure of personal information in the form that it is processed may result in the disclosure of confidential or proprietary information,

- giving access may cause a third party to refuse to provide similar information to JM,
- the information was collected in furtherance of an investigation or legal dispute, instituted or being contemplated,
- the information as it is disclosed may result in the disclosure of another person's information,
- the information contains an opinion about another person and that person has not consented, and/or
