1. Background

The Risk Ethics & Compliance (REC) Department is responsible for leading, supporting and facilitating governance, risk and compliance processes for the Joburg Market (JM). In fulfilling this responsibility, and in line with the performance target set, the Department needs to periodically perform assessments to indicate the progress made by the organisation in developing and embedding systems and processes for governance, risk and compliance. The integrity of such assessments is greatly enhanced when performed by an independent and objective party.

The REC Department has previously performed a self-assessment of the maturity of its systems of managing risk for the 2024/25 financial year. The assessment was performed utilising an approved model of capability maturity, which considered and measured the maturity of the Organisation's risk management systems against six themes, namely:

- Culture
- Strategy & Policy
- Structures
- Methodology
- Processes
- Systems

The appointment of a service provider to conduct a risk maturity assessment is required as it will provide a more comprehensive assessment, access to specialised expertise, and clearly defined improvement strategies.

The information gathered from the risk maturity assessment will be helpful in informing JM's strategic risk management plans, enhancing decision-making processes, and finally contributing to the overall success and sustainability of the organisation.

2. Terms of Reference

The appointed service provider will be required to do the following:

- Provide a risk maturity assessment report with findings, improvement areas and recommendations including ways and means through which the Organisation can elevate its level of risk management maturity.
- Meet the Risk Management Stakeholders (selected from all relevant lines of defense) and identify existing risk management capabilities
- Meet with key JM key stakeholders to better understand how well controls are implemented and identify any undocumented good practice areas to evaluate the implementation effectiveness of controls

3. Services Required

Determine the risk management capability maturity levels, taking into account:

- The approved risk management capability maturity model;
- The outcomes of the previous risk management capability maturity level assessments performed (to be provided); and
- An analysis and assessment of the appropriate capability maturity themes to determine if there has not been any changes in the risk management control environment that lead to significant changes in the overall capability maturity level.

On the basis of the above, come to a conclusion on the level of maturity for systems of risk management as at the end of the 2024/ 2025 financial year.

4. Deliverables

- The deliverable for the assignment is a written report (executive summary and a comprehensive report) outlining the findings of the risk management maturity assessment.
- All reports must be provided in a signed portable document formats (PDF) and editable MS-Word versions.
- An executive summary of the assessment process, its outcomes and recommendations in a presentation format (MS PowerPoint).

1.3 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.4 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;

- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)

This section sets out how personal information will be collected, used and protected by Joburg Market hereinafter referred to as “JM”, as required by the Protection of Personal Information Act. The use of the words “the individual” for the purposes of this document shall be a reference to any individual (bidder) communicating with JM and/or concluding any agreement, registration or application, with the inclusion of each of those individuals referred to or included in terms of such agreement, registration or application.

1. What is personal information?

The personal information that JM requires relate to names and surnames, birth dates, identity numbers, passport numbers, demographic information, education information, occupation information, health information, addresses, memberships, and personal and work email and contact details.

2. What is the purpose of the collection, use and disclosure (the processing) of personal information?

JM is legally obligated to collect, use and disclose personal information for the purposes of:

- Reporting initiatives to the City of Johannesburg Municipality;
- reporting to National Treasury all contracts awarded;
- obtaining information related to Tax Compliance information from SARS;
- Verifying information on the National Treasury database of defaulters;
- evaluating and processing applications for registration on the database;
- compiling statistics and other reports;
- providing personalised communications;
- complying with the law; and/or
- For a purpose that is ancillary to the above. Personal information will not be processed for a purpose other than what is identified (the purpose) above without obtaining consent beforehand.

3. How will Joburg Market process personal information?

JM will only collect personal information for the purpose as stated above. Information will be collected in the following manner:

- directly from the individual;
- from service providers who provided with services or goods to JM;
- from JM’s own records relating to previous supply of services or goods; and/or
- from a relevant public or equivalent entity.

4. To whom will personal information be disclosed?

The personal information may be disclosed to other relevant public or other entities on whose behalf we act as intermediaries, other third parties referred to above in relation to the purpose or who are sources of personal information, service providers such as professional bodies who operate across the borders of this country (trans border flow of information) where personal information must be sent in order to provide the information and/or services and/or benefits

requested or applied for. In the event of another party/ies acquiring all of or a portion of JRA's mandate or functions, personal information will be disclosed to that party but they will equally be obliged as we are, to protect personal information in terms of this policy and the law.

5. Consent and Permission to process personal information:

I hereby agree with the policy and provide authorisation to JM to process the personal information provided for the purpose stated:

- I understand that withholding of or failure to disclose personal information will result in JM being unable to perform its functions and/or any services or benefits I may require from JM.
- Where I shared personal information of individuals other than myself with JM I hereby provide consent on their behalf to the collection, use and disclosure of their personal information in terms of this personal information policy and I warrant that I am authorised to give this consent on their behalf.

- Individuals are encouraged to ensure that where personal information has changed in any respect to notify JM so that our records may be updated. JM will largely rely on the individual to ensure that personal information is correct and accurate.
- The individual has the right to access their personal information that JM may have in its possession and are entitled to request the identity of which third parties have received and/or processed personal information for the purpose. Please note however, that any request in this regard may be declined if:
 - the information comes under legal privilege in the course of litigation,
 - the disclosure of personal information in the form that it is processed may result in the disclosure of confidential or proprietary information,

- giving access may cause a third party to refuse to provide similar information to JM,
- the information was collected in furtherance of an investigation or legal dispute, instituted or being contemplated,
- the information as it is disclosed may result in the disclosure of another person's information,
- the information contains an opinion about another person and that person has not consented, and/or
- the disclosure is prohibited by law.
