4. In the event of a mistake having been made on the price schedule it shall be crossed out in ink and be accompanied by an initial on each and every price alteration. Corrections in terms of price may not be made by means of a correction fluid such as Tipp-Ex or a similar product. If correction fluid has been used on any specific price item, such item will not be considered. No correction fluid may be used in a Bill of Quantities where prices are calculated to arrive at a total amount. If correction fluid has been used, the whole quotation will not be considered. 1. Project Description

Appointment of a service provider to facilitate the ICT strategy and smart market alignment workshop at Joburg Market

2. Background

Joburg Market plays a strategic role in national and regional food security, agricultural value chains, and urban economic development. As one of the largest fresh produce markets in Africa, Joburg Market is required to operate efficient, transparent, and technology-enabled systems that support producers, traders, buyers, regulators, and the City of Johannesburg.

In response to increasing operational complexity, data-intensive trading environments, and evolving service delivery expectations, Joburg Market has embarked on a digital transformation journey guided by its Smart Market vision and emerging Data Strategy.

This includes strengthening:

- Digital trading and financial systems
- Market information and analytics platforms
- Data governance and commercialisation models
- Cybersecurity and system resilience
- Institutional ICT governance and capacity

To advance this agenda, Joburg Market intends to convene a two-day ICT, Smart Market and Data Strategy Development Workshop to align leadership, management, and technical teams around a shared digital future and implementation roadmap.

(A). Purpose of the Assignment

The purpose of this assignment is to design and facilitate a structured two-day strategic workshop that will support Joburg Market in:

- Consolidating its Smart Market and Data Strategy direction

CONSENT AND ACKNOWLEDGMENTS IN TERMS OF THE PROTECTION OF PERSONAL INFORMATION ACT 2013 (POPI)

This section sets out how personal information will be collected, used and protected by Joburg Market hereinafter referred to as “JM”, as required by the Protection of Personal Information Act. The use of the words “the individual” for the purposes of this document shall be a reference to any individual (bidder) communicating with JM and/or concluding any agreement, registration or application, with the inclusion of each of those individuals referred to or included in terms of such agreement, registration or application.

1. What is personal information?

- directly from the individual;
- from service providers who provided with services or goods to JM;
- from JM’s own records relating to previous supply of services or goods; and/or
- from a relevant public or equivalent entity.

4. To whom will personal information be disclosed?

5. Consent and Permission to process personal information:

 - the disclosure of personal information in the form that it is processed may result in the disclosure of confidential or proprietary information,

- giving access may cause a third party to refuse to provide similar information to JM,
- the information was collected in furtherance of an investigation or legal dispute, instituted or being contemplated,
- the information as it is disclosed may result in the disclosure of another person's information,
- the information contains an opinion about another person and that person has not consented, and/or
- the disclosure is prohibited by law.
